Based on the recognition accorded by the National Council of Teacher Education, Bangalore and the recommendations of the University Scrutiny Committee, the University has accorded approval for grant of provisional affiliation to Riyan College of Education, Khasara / Plot No.112, Venkatadripalem - Village, Miryalaguda — Post, Taluk & City Nalgonda Dist. 508 207 for the academic year 2020-21 to offer B.Ed. Course with an intake of 100, subject to the fulfillment of the following conditions and general rules of affiliation:

## **CONDITIONS:**

- To appoint teaching staff through duly constituted selection committee as per NCTE 2014 norms representing all Methodologies and obtain the Approval from the Registrar, MGU for the New staff including Principal at the beginning of the academic year 2020-21. The details of approved lecturers along with their photographs are to be uploaded to University website www.mguniversity.in and a hard copy to be submitted to the University.
  - 2. Principal should be appointed with Ph.D. in Education.
  - 3. To Purchase books worth Rs.15, 000/-
  - 4. Students' attendance registers should be maintained properly.
  - 5. ICT laboratory should strengthen as per norms.
  - 6. Salaries to the staff should be paid regularly through bank only.
- 7. Scrupulously follow intoto vide Lr.No.5733/UE/2015, Date:-26-11-2016 by Government of Telangana Higher Education (UE) Department.
- 8. Bio-metric attendance should be uploaded through the Vidyawaan Portal. (www.vidyawaan.nic.in)
- 9. Anti-ragging committee should be formed posters are to be displayed.
- 10. Teaching diaries and student attendance registers are to be maintained properly.
- 11. Three Governing Body meetings are to be conducted in an academic year associating University nominee and the resolutions are to be submitted through University nominee to the University.

- 12. The compliance report with relevant evidences must be forwarded through University nominee on the Governing Body and to be submitted in time to the University.
- 13. The Purchase of guides or study material in any form cannot be considered as part of the books purchase for the Library.
- 14. All the labs are to be established and strengthened with relevant equipment infrastructure also put in to practice regularly.

The Management is directed to submit the compliance Report on the fulfillment of the above conditions within one week with documentary evidence wherever necessary, through Governing Body member nominated by the University in the following prescribed proforma.

## GENERAL CONDITIONS TO BE FULFILLED BY ALL COLLEGES:

- 1. That they should appoint teaching staff through duly constituted selection committee as per MGU 2014 norms, associating the University Nominee on the Selection Committee and Subject Expert representing all Methodologies and obtain the Renewal/Approval from the Registrar MGU for the Existing / New staff at the beginning of the academic year whenever required.
- 2. As per NCTE norms the Management has to shift the College to its own premises within (3) academic years from the date of establishment.
- 3. To provide spacious rooms for classes and laboratories and separate toilets for boys and girls as suggested by the ScrutinyCommittee.
- 4. Consolidated attendance statement is to be prepared every year and submit to the University.
- 5. It is made clear to all the colleges that if the above conditions are not fulfilled by the college(s) within the stipulated time, such colleges(s) will be disaffiliated under intimation to NCTE/State Government.
- 6. To appoint a qualified librarian
- 7. Attendance registers and teaching diaries are to be maintained properly. Attendance to be marked in the class room only.

8. College should follow MGU almanac strictly.
