WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 MD Riyan Ahamed Educational Society, Plot No. H.No. 9-33, Seetharampuram Road, Miryalaguda Village, Post & Taluk, Nalgonda District-508207, Andhra Pradesh has applied for grant of recognition to Riyan College of Education, Sy.No. 112, Venkatadripalem Village, Miryalguda Village & Post, Nalgonda District-508207, Andhra Pradesh for B.Ed course online on 31.12.2012 for one year duration under Section 14 (1) of the NCTE Act, 1993 and received in the Southern Regional Committee NCTE on 04.01.2013.

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Southern Regional Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Riyan College of Education, Sy.No. 112, Venkatadripalem Village, Miryalguda Village & Post, Nalgonda District-508207, Andhra Pradesh for conducting B.Ed course of one year duration with an annual intake of 100 students from the academic session 2014-15 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- 4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:

 - Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - Name of faculty members who left or joined during the last, quarter;
 - Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter,
 - i) The institution shall be free to post additional relevant information, if it so desires
 - Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.
- If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
